- We have \$2,143.63 in the bank.
- We have paid all of our annual bills for 2021: post office and registration with the State of NV.
- We have submitted our invoice and request for \$500.00 from Dept. of Public and Behavioral Health, MCAH, Title V MCH grant. This is for the Diversity in Lactation sponsorship.

- Alex submitted the grant application to Renown for \$1,000.
- We received our donation from Anthem. I am waiting to deposit the check until I receive the W9 form. We will need this for taxes next year. I will email the representative again tomorrow.
